In addition, volunteers must submit evidence every four years that they are free from active tuberculosis.

## Volunteer Driver Form

I, \_\_\_\_\_, volunteer to transport student(s) of the Woodside Elementary School District to and from school sponsored events in my private vehicle. I affirm that:

- To my knowledge, my vehicle is fit for its intended purpose, is safe, and has a manufacturer installed safety belt/harness system for the number of passengers I agree to transport. At any one time, I will only transport the number of passengers for which my vehicle has an operating safety belt/harness system (up to 8 passengers, maximum).
- I acknowledge that the vehicle being used to transport students is manufactured to transport no more than 9 people (8 passengers and 1 driver). I further understand that it is against California State law to transport students in a vehicle that is designed to seat more than 9 people.
- Operation of my vehicle is and will continue to be covered by my automobile liability insurance, which provides at least \$100,000/person and \$300,000/accident on liability, and \$5,000 property damage/accident. If I have an accident while transporting student(s), my insurance will be primary.
- At all times that I am transporting students in my vehicle, only I will be the driver.
- I am familiar with the rules of the road and will at all times drive in compliance with them, and all other provisions of the California State Vehicle Code.

**If an automobile accident or injury occurs while my vehicle is being used to transport students, and it is alleged that I was negligent in my operation of the vehicle and/or that I violated any of the above representation, I agree to hold harmless, indemnify and defend the school district and its employees from any claim, demand, action or lawsuit against them arising out of that accident.**
